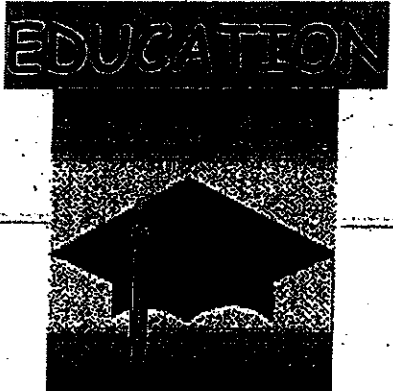

COMMUNITY ACTION: 733-9351 \$35.00 per year emergency medication allowance per family. Criteria is to meet the agencies income requirements which works at 125% of poverty guidelines. After that they will refer local churches or the county.

MVRMC DIABETES EDUCATION: 737-2903 Contact Janet R. Or Vicki Berg at extension 2903. Any funds they have come from the Foundation and each person will need meet criteria that the Foundation has set. 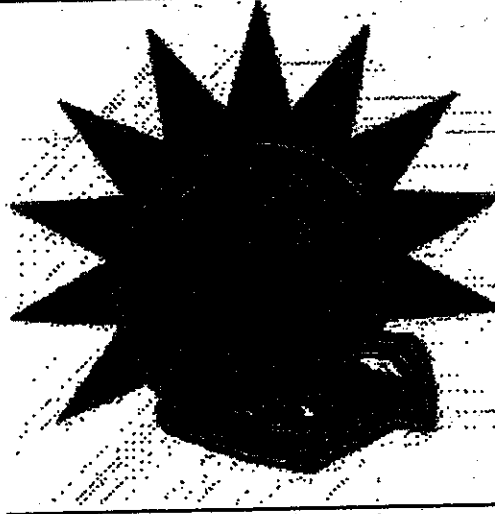

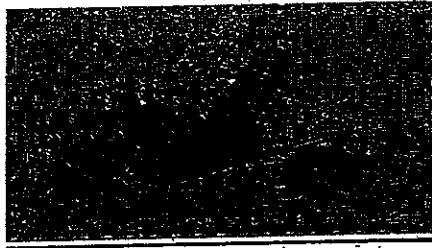
